



**Z. HAYDU MFG. CORP.
ULTRASONIC SCALER INSERT
LIMITED WARRANTY**

Z. Haydu Manufacturing Corporation (ZHMC) warrants to the first consumer purchaser that its ultrasonic scaler inserts (THE PRODUCT), when shipped in its original container, be free from defects in workmanship and materials, and agrees that it will, at its option, either repair the defect or replace the defective product or part thereof at no charge to the purchaser for parts or labor for a period of six (6) months from date of purchase.

This warranty does not apply to any product which has been altered or modified in design or construction. In no event shall Z. Haydu Mfg. Corp. be liable, or in any way responsible for any damages or defects in the product which were caused by improper sterilization, dropping the insert, reshaping the tip or attempted repairs performed by anyone other than Z. Haydu Mfg. Corp. This warranty does not apply to any consumable item, i.e. the external o-rings.

In order to enforce the rights under this limited warranty, the purchaser should request an RMA number from ZHMC. Ship the steam autoclaved product (unless unopened) in its original plastic tubes and caps to ZHMC, 1980 Grant St., Hollywood, Florida 33020. Provide your company name, Scaler Date Code and details of the problem you are experiencing. Additionally, please reference your Purchase Order number or our Invoice number.
